# **REUNION 2021**

...and the 2021 reunion goes to....NORTHERN VIRGINIA

How the selection process worked: At the business meeting during the 2019 reunion, members present suggested locations for the 2021 reunion. The dozen or so suggested locations were then narrowed down to the three most popular choices. Those locations (Northern Virginia; San Antonio, TX and Savannah, GA) were then passed to our reunion planner, Sherry of A Complete Reunion for her input as to costs, availability of tours, and other factors. Because of problems with planning reunions in Savannah in the past, Sherry suggested substituting Mobile, AL for Savannah. The membership agreed to that swap. Each member was then emailed more detailed info on each of the three sites, and asked to vote on their preferred site. Northern Virginia received 11 of 20 first place votes cast.

Details are still being worked out, but the current option is to stay in a hotel near Dulles Airport, with the reunion occurring in mid to late June or early September 2021.

# Final Farewell

- RM3 Stafford Cumberledge, Thomas C. Hart plank owner, passed away on July 16th. He was part of the comm crew who came from Navcomsta Keflavik, Iceland, and served on the pre-commissioning and commissioning crew.

- Captain Skip MacMichael, who served as Commanding Officer of Thomas C. Hart from 1983-1985 also passed away in July. Many of you who did not have the opportunity to serve with him may remember him as a frequent attendee at our reunions. The following message was received from his wife Jo:

#### Dear Family and Friends,

Just hours after my last posting, Skip died peacefully. I had whispered to him that it was the 4th of July -- a good day to die as had patriots John Adams and Thomas Jefferson. We were alone together -- just the two of us as we often preferred to be -- when he took his last few breaths. I am incredibly sad to lose him but so relieved that he is no longer suffering. It was my good fortune that my nephew Matt Balzano who has a gift for praying arrived minutes afterward. He, my sister Denise, our son Jim, his wife Shannon and their sons John (20) and Ryan (16) were with me for the rest of the day. I am grateful to Capital Caring Hospice folks who helped make Skip's last few weeks much easier. Both of us were thankful for the wonderful care Skip received from the doctors, nurses and staff at Walter Reed National Military Medical Center (especially Dr. Benjamin Potter, Dr. Jeremy Perkins, Nurse Practitioner Brenda Davis, Ms Fatu Fofana and the nurses in the infusion center) as well as Dr. Christian Meyer, a sarcoma specialist at Johns Hopkins Cancer Center. Unbelievably, we were surprised by weekend calls from Dr. Meyer checking up on Skip and offering encouragement and advice on alternative therapies. We were very fortunate that both he and Dr. Perkins willingly consulted on Skip's choices of care -- we know that doesn't always happen.

The family will receive guests from 6:00 - 8:00pm Friday, July 12 at Demaine Funeral Home, 502S Washington Street, Alexandria, VA 22314. A service commemorating Skip's life will be held Saturday, July 13 at 2pm at St. Luke's Episcopal Church, 8009 Fort Hunt Road, Alexandria, VA 22308. There will also be a visitation on Friday evening, July 12 at Demaine's Funeral Home, 520 S. Washington St, Alexandria, VA 22314. Skip will be interred at Arlington National Cemetery at a future date.

Thank you to all of you -- our friends and family who supported, prayed for and loved us.


